General Terms and Conditions

1. We agree that the Bank may decide on the choice of any correspondent bank to which the documents shall be sent for collection.
2. We agree that the Bank shall not be responsible for any act, omission, default, loss in exchange or loss of item or its proceeds during transmission, or in the course of collection.
3. Until actual payment has been received by the Bank, the Customer shall reimburse the Bank for any advance made in anticipation of payment of the collection.
4. We undertake to pay all collection charges, including charges not paid by the drawee.
5. We agree that the Bank assumes no responsibility for the authenticity or genuineness of documents delivered to the Bank, nor for the quantity, quality, condition, genuineness, identity, title or delivery of the goods to which the documents relate.
6. We undertake and agree to indemnify the Bank on a full indemnity basis from and against all liabilities, actions, suits, proceedings, claims, damages, expenses, losses and cost including legal cost of whatever nature.
7. Documentary Collections are subject to the Uniform Custom Rules for collection and drawings under Documentary Credits are subject to Uniform Customs and Practices for Documentary Credits, International Chamber of Commerce that are prevailing or any future revision thereof.
8. By signing this application, we hereby give prior consent to the sale of the goods or any part thereof and no future consent to or notice of the sale is required.
9. In consideration of your negotiating or paying, at our request for export bill drawn under Documentary Collection or Documentary Credit.
 - a) We hereby irrevocably and unconditionally undertake and agree to indemnify the Bank, the Bank's successors and assigns in full and at all times to keep the Bank, the Bank's successors and assigns fully and completely indemnified from and against all liability, claims, demands, actions, proceedings, payments (including but not limited to payments under the Letter of Credit), losses and expenses whatsoever including but not limited to legal costs as between solicitor and client which may be made or taken or incurred or suffered by the Bank in connection with our request herein including but not limited to those liabilities relating to or arising from any and all discrepancies that may exist between the documents as called for in the terms of the Letter of Credit and the documents enclosed with our application, regardless of whether or not such discrepancies are identified or advised by the Bank.
 - b) We further irrevocably and unconditionally undertake to refund to you on demand, the value of Bill and/or Documents received by us and pay you all charges, expenses and interest at such rate from time to time as determined by you in the event of the non-acceptance or non-payment in respect of the documents by the issuing bank, nominated bank and/or confirming bank due to whatever reasons including (without limitation) any disagreement between you and any of them in respect of the conformity of the documents.
 - c) We agree that your negotiation of the documents under Documentary Collection or Documentary Credit shall be on a full recourse basis.
10. This Terms and Conditions shall be governed by and construed in accordance with the laws of the Union of Myanmar. We agree to submit to the nonexclusive jurisdiction of the courts in Myanmar in respect of any disputes arising out of or in connection with this agreement. Without prejudice to the foregoing, we undertake not to commence proceedings or suits against the Bank in the courts of any other jurisdiction. In the event of any proceedings or suits commenced by us against the Bank, we agree that Myanmar Courts shall have exclusive jurisdiction in respect of any disputes arising out of or in connection with this Terms and Conditions. We agree to waive and do so waive any right vested on us by the laws of the jurisdiction in which we carry on business to challenge the validity or legality of any part of this provision.
11. Any award or decision of the court shall be final, binding and enforceable and the parties shall strictly comply with its decision. Costs shall be borne as determined by the Court.
