Terms and Condition for Online Banking through internet

SCOPE

The Online Banking Services facilitate access to information of your accounts with United Amara Bank (“UAB”) and to carry out certain banking services (including view of your statements and transfer of funds). Online Banking Services is available 24 hours daily. Occasionally, Online Banking Services may not be available due to regular maintenance or system update.

CONDITIONS OF USE

You agree to use the Online Banking Services solely in accordance with these Terms and Conditions. UAB has the discretion from time to time to determine the type, specifications and/or configuration of telecommunications equipment acceptable for the purpose of providing the Online Banking Services. You agree and undertake:

- (a) Not to use an equipment, device, software or material which you know or have reason to suspect contains any viruses, malicious code or damaging components which any interfere with the operation of the Online Banking Services or corrupt data or software on or provided through the Online Banking Services; and
- (b) To use the Online Banking Services in conformity with all applicable laws, the acceptable use policies of any connected computer networks and any applicable internet standards.
- (c) That all Authorized Persons in this Form shall have access through the internet to all available information in your account.

DISCONTINUATION

The Online Banking Services may not be available to you for security and/or technical reasons and for which we may not give you prior notice or reason. The Online Banking Services may be withdrawn for security and/or technical reasons without giving you any reason or notice. You may terminate the Online Banking Services by giving us seven (7) days prior written notice. Termination will not affect any rights or obligations accrued prior to the effective date of termination.

ELECTRONIC INSTRUCTIONS

You agree to be bound by any access or use of the Online Banking Services (whether such access or use are authorized by you or not). Any risks of misunderstanding, error, loss, damage or expense resulting from the use of the Online Banking Services are entirely at your own risk and UAB shall not be liable.

You acknowledge and agree that UAB may at any time, at UAB’s sole discretion and without stating reasons, require that you identify yourself by alternative means, and require any Electronic Instructions to be confirmed through alternative means (in writing given in person at a branch, by fax, and etc.

SECURITY ISSUES

You shall be responsible for obtaining and using the necessary software and/ or device, hardware and/ or equipment necessary to obtain access to the Online Banking Services at your own risk and expense. You acknowledge the following internet related risk:

- (a) Insufficient technical knowledge and lack of safety precautions can make it easier for unauthorized third parties to access your systems or devices (for example, insufficiently protected storage of data on the hard disk, file transfers and monitor emissions), and it is your responsibility to take the necessary security precautions.
- (b) Third parties could gain unnoticed access to your computer system and detect your access to the Online Banking Services and your communications with UAB.
- (c) Viruses and other malicious code may interfere with the Online Banking Services, the Channel, the web browser or any relevant telecommunication device or computer systems.

AUTHORIZED PERSONS’ DEED OF INDEMNITY

All transactions arising from the use of Online Banking in the account shall be binding on all the Authorized Persons, jointly and severally. Authorized Persons agree to fully indemnify UAB in any way for any unauthorized or erroneous instructions or orders.

INDEMNIFICATION

You agree and undertake to fully indemnify UAB, our affiliates, service providers, subcontractors, and agents, and to hold each of the aforementioned parties harmless, from and against all liabilities (including settlement sums), losses, charges and expenses (including legal fees and disbursements on a solicitor-client basis) directly or indirectly from or by reason of or in relation to the use, misuse or purported use or misuse of the Online Banking Services.

UAB reserves the right to revise the terms and conditions contained herein, and, are binding.
